CHAPTER 13 DEBTOR VERIFICATION OF DIRECT PAYMENTS

Considering the need for accurate information in order to allow the court and parties in interest to consider confirmation of chapter 13 plans,

IT IS ORDERED that:

- (a) Before the confirmation hearing, debtors making payments directly to creditors outside the plan shall file a verification, signed under penalty of perjury, that all direct payments due before the confirmation hearing—including without limitation residential and other mortgage, vehicle loan and domestic support obligations—have been made.
- (b) If the debtor is represented by an attorney, the attorney also shall certify that based on review of the debtor's documentation, the debtor has made all post-petition direct payments.

IT IS FURTHER ORDERED that Local Form 7, attached to this order as exhibit A, be used for compliance with this rule.

IT IS FURTHER ORDERED this rule is effective December 18, 2019.
